THE HISTORY CORNER By: Carolyn Starks Saxon, Esquire

"Histories make men wise..." 1

The History Corner is a new feature of the Prince George's County Bar Association's newsletter. It will contain information related to the history of Prince George's County.

This is the beginning of a series regarding the impact of one good man on the fabric and history of the Prince George's legal community as told through the eyes of some of the individuals who were touched by his life. The name of this individual is Arthur A. (Bud) Marshall, Jr. The series will begin with a first- hand account of his accomplishment by his friend, Judge Vincent Femia.

A CONVERSATION WITH JUDGE VINCENT FEMIA

Judge Vincent Femia is a respected and beloved member of the Prince George's County Bar Association. The following article is based on a series of conversations I had with Judge Femia about his background and memories as a lawyer in Prince George's County, Maryland. He also wrote portions of the article.

Judge Femia was born in Philadelphia,

Pennsylvania. The day after graduating from Haverford Senior High School in Haverford, Pennsylvania he moved to Washington, D.C. to take up a position as a fingerprint searcher for the F.B.I. He attended night school at George Washington University from which he graduated in 1959 with a B.A. degree in accounting.

At 4:30 in the afternoon of June 23, 1954, his first full day on the job as a fingerprint searcher, he boarded the #40 streetcar outside of the old FBI Ident building for his ride home to his lodgings in Mt. Pleasant. Also riding that streetcar was a young lady by the name of Elizabeth Ward Bell, a name card searcher for the F.B.I. They were married on June 23, 1957 at 4:30 pm. She is a stickler for details. Fifty-three years later, they are the proud parents of three adult children and 6 grandchildren. For the past 36 years, Judge Femia and his wife have resided in Accokeek, Maryland.

Upon graduating from GWU, with an undergraduate degree in accounting, Judge Femia literally walked across the campus quad and began attending George Washington University Law School, from which he graduated in October, 1961.

In January, 1960, he passed the certified public accounting examination in the State of Maryland. He sat for the July, 1961 bar examination and he was admitted into the Maryland State Bar Association in October, 1961.

From 1957 - 1961 he clerked for Leonard C. Collins, his former professor of law in undergraduate school, in Mr. Collins' Washington, DC law office. In late 1961, he opened his own law practice in the Glassmanor Apartments across the street from the Eastover Shopping Center in Oxon Hill, Maryland, located in Prince George's County. His business partner was Howard L. Stern.

In 1962 Judge Femia embarked upon a course of action that would change the direction of his professional career. Because of his accounting background, he was asked to run for election as Treasurer for Prince George's County on the "Independent Democrat Ticket". The other candidates on the ticket included Arthur A. (Bud) Marshall, Jr. running for the office of State's Attorney and Gladys Spellman running for the office of County Commissioner. The members of the ticket were young, political upstarts outside of the established political spectrum. Judge primary campaign plank was Femia's that the office of Treasurer should be abolished and replaced with a professional

finance officer to be a county employee. Gladys Spellman's election as County Commissioner launched her political career and in November, 1975 she was elected to the US House of Representatives. In November, 1980, she developed a medical condition which prevented her from completing her term in office. A special election in the spring of 1981 was held and Steny Hamilton Hoyer, then President of the Maryland State Senate, assumed the position as the representative from the 5th Congressional District in the US Congress. Judge Femia lost his bid to be County Treasurer, but he accepted a position with Bud Marshall.

On January 7, 1963, Bud Marshall was installed as the State's Attorney for Prince George's County. He hired Edward P. Camus, Howard S. Chasanow, Vincent J. Femia, Lloyd James, Richard Painter and James H. Taylor to serve as Assistant State's Attorneys. Bud Marshall's 24 years of service as the State's Attorney literally and figuratively changed the substance and complexion of the Office of the State's Attorney in Prince George's County.



Drafting an Arbitration Provision-The Virtual Courthouse Way

VirtualCourthouse provides a fresh new approach to arbitration. An approach which provides flexibility and cost savings not available through AAA, JAMs, National Arbitration Forum. Have you noticed that arbitration has become more time consuming and more expensive as each year passes. How has that happened when the whole notion, 50 years ago was, for Arbitration to reduce the cost and time of litigation? Well, one observation would lay the blame at the foot of trying to provide too many rules to cover too many possibilities. Take a look at any major ADR provider's rules - in many cases they are more involved than a court's rules of procedure.

Here is how the unaware gets caught up in that dilemma. Client engages a lawyer to draft a contact. Lawyer suggests to client that it is best to insert a provision in the contract agreeing to arbitrate any dispute. Client is aware of all of the horror stories about the cost of litigation and says "by all means keep me out of court". Lawyer inserts a provision which says - "Any dispute

between the parties will be arbitrated in accordance with the rules of the American Arbitration Association." Two years go by and the parties have a major disagreement. One party looks up the AAA rules and finds out that the AAA rules require the claim to be filed with AAA. The parties now have no choice about how much will be charged or who the arbitrator will be. AAA's panel of neutrals are not competitively formed. AAA restricts the number of neutrals never a good idea as that type of activity keeps prices high and many highly qualified neutrals off of AAA panels. They have agreed to a dispute resolution service that provides little flexibility - many would say more expensive than court. Many attorneys find the AAA administrative process to be cumbersome, unwieldy and time consuming.

What then is the best way to draft an arbitration provision in a contract? The first order of business is to understand the legal territory. Generally speaking, arbitration agreements are enabled by Federal and State law-the Federal Arbitration Act or the Uniform Arbitration Act. Both Federal and State Acts provide similar provisions, although there are significant differences in some special areas. Both Acts are similar in that they provide for:

- 1. Enforcement of agreements to arbitrate:
- 2. The appointment of an arbitrator where the parties cannot agree;
- 3. The subpoena of witnesses;
- 4. The confirmation of awards by judgment in court.

When drafting an arbitration provision in a contract the important items to consider are:

- 1. Administration Cost
- 2. Identity of the neutral
 - a. Greatest number of qualified neutrals to select from
 - b. Closed panels increase costs and are anti-competitive
 - c. Allowing the parties the opportunity to agree on a neutral

- 3. Neutral compensation
- 4. Simplification of the rules without sacrificing important legal rights
- 5. Flexibility Does an ADR provider have the ability to change?

Reduce Costs Adopt new technology

- The key issue here is to provide the maximum amount of flexibility so that a fair, fast and inexpensive conclusion can be reached. When the parties reserve the right or alternative to select the ADR solution provider until a dispute arises they build in cost flexibility. The alternative is to select and name an ADR solution provider that has the same flexibility built in. VirtualCourthouse provides that flexibility. If the parties cannot agree then either party may petition a court of competent jurisdiction to appoint a neutral.

Judge William D. Missouri Retires

Administrative Judge for Prince George's County, 7th Circuit, Has Served on Bench for Quarter-Century


Chief Judge William D. Missouri, administrative judge of the Prince George's County Circuit Court and the 7th Circuit, retired Sept. 3 after more than 25 years on the bench.

Judge Missouri was appointed to the Prince George's County Circuit Court by Gov. William Donald Schaefer in December 1987, and was elected to a 15-year-term in November 1988. Gov. Robert L. Ehrlich reappointed Judge Missouri in November 2003, and he was then re-elected for a second term in November 2004.

Judge Missouri was named county administrative judge in October 1992. He was appointed administrative judge for the 7th Circuit, and has served in that capacity since May 1997. As the county administrative judge, he is responsible for the daily operations of the Circuit Court in Prince George's County, including the supervision of judges, officers and employees, the assigning of judges to cases, and the court's budget. As administrative judge for the 7th Circuit, Judge Missouri is also responsible for the administration of the courts within the judicial circuit, including the supervision of Calvert, Charles and St. Mary's counties' administrative judges.

Before joining the Circuit Court, from 1985 through 1987, Judge Missouri served on the District Court of Maryland, sitting in Prince George's County. He served as that District's administrative judge from 1987 until his appointment to the Circuit Court.

"Judge Missouri has been an invaluable asset and a superlative leader for the Maryland Judiciary, serving the citizens of this State in many important capacities during his long and distinguished career," said Chief Judge Robert M. Bell of the Maryland Court of Appeals. "On behalf of the Judiciary, I express profound gratitude for Bill's extraordinary and selfless service to the people of Maryland, and in particular for his stewardship of the Prince George's County Circuit Court and the 7th Circuit."
