

Family Law, Matters - Suggestions and Practice Considerations for Family Law Attorneys

- Prepare your entry of appearance on your word processor so it is legible. File your appearance with the court clerk and pay the appearance fee prior to the court hearing. Do not ask the courtroom clerk for a Line form to enter your appearance after the hearing starts. It gives the impression that you are not prepared.
- 2. Get date stamped copies of all pleadings you file with the court clerk's office.
- 3. BE ON TIME for your court hearing. Arrange to meet your client and witnesses at least 45 to 60 minutes prior to your scheduled time. Give your client / witnesses directions to the courthouse and where to meet you there. People often have trouble finding their assigned courtroom. You may call the Office of Calendar Management the afternoon prior to your hearing date to find out which Master / Judge is hearing your case and the courtroom number.
- 4. Time needed for hearings. Schedule your case for a realistic amount of trial time.
- Thoroughly review your file prior to the hearing date. Make sure that all complaints and counter-complaints are answered or are otherwise at issue (e.g., by an order of default).
- 6. What relief is your client requesting? Do you have the evidence to support that request?
- In an absolute divorce case, even if you have fault grounds, always plead the no fault ground of 12 month separation if you have it. It is the easiest ground to prove and corroborate.
- 8. Effective October 1, 2011, the absolute divorce grounds of one year voluntary separation and two year separation no longer exist. See Family Law Article, section 7-103. The new ground for absolute divorce is 12 month separation. You no longer need to ask if there is any reasonable expectation of a

- reconciliation as it is not a factor for a 12 month separation divorce.
- 9. Corroboration. FLA Section 7-101(b) provides that a court may not enter a decree of divorce on the uncorroborated testimony of the party who is seeking the divorce. Does your client have a witness who can corroborate the alleged grounds for divorce?
- 10. Age of parties / witnesses: Many people are sensitive about their age. Unless age is a factor (e.g., in alimony and property cases) you do not need to ask a witness his/her age. It is sufficient to ask if he/ she is over the age of 18 years.
- 11. Prepare your client and witnesses for the hearing. Before the hearing make sure you review the questions you will ask them during the hearing.
- 12. Exhibits: Make copies of your exhibits before you come into the courtroom. If your client provides you with some documents on the day of the hearing, go to the law library before the hearing and make copies. Do not ask the courtroom clerk to make copies for you. Prepare multiple copies of each exhibit so the Master / Judge and opposing counsel can look at them while you are questioning your client about the exhibit.
- 13. TIME STANDARDS: Cases are to be concluded within ONE YEAR from the date of filing the initial pleading. If you have a case where you know it is likely the defendant cannot be located and you will be seeking alternate service, promptly get all your information together which will support your motion for alternate service so you can conclude your case within time standards.
- 14. Complaints for limited divorce: If you are seeking a limited divorce, be prepared to proceed on it at the hearing. Don't ask for a continuance on the trial date because your case will be ripe for an

- absolute divorce in a few months and you plan on filing supplemental pleadings.
- 15. Discovery: If property, alimony, custody and child support are issues in your case, get an early start on discovery. File your discovery requests with your complaint.
- 16. File a counter-complaint. If you have a counter-complaint which is at issue (by an answer or an order of default) you can go forward with it on the trial date. It often happens that the plaintiff does not have a corroborating witness or fails to prove his/her complaint. You can then go forward with your counter-complaint. Make sure your client is present with a corroborating witness as to the counter-complaint.
- 17. Signing of pleadings: Please note the requirements of MRP, Rule 9-202. In cases in which divorce, annulment, alimony, child support, custody or visitation is sought a party shall PERSONALLY sign each pleading filed by that party.
- 18. Requests for restoration of former name: Please note the requirements of FLA 7-105. Ask your client if her request is for any illegal, fraudulent or immoral purpose.
- 19. Review the court file jacket periodically. Sometimes self-represented litigants file pleadings or file letters and other material which they do not serve on the opposing party / counsel.
- 20. Marital property cases: A joint statement of marital and non-marital property (MRP 9-207) must be filed at least 10 days before the scheduled trial date.

Review the provisions of the FLA, Property Disposition in Annulment and Divorce, Section 8-201 et seq. The court may transfer ownership of an interest in specified property, grant a monetary award, or both, as an adjustment of the equities and rights of the parties

concerning marital property. This essentially involves a 3 step process. The court must determine which property is marital property (FLA 8-203); value all marital property (FLA 8-204), and consider the 11 factors set forth in FLA 8-205.

- 21. Child custody cases: In child custody cases there are many factors for the court to consider regarding legal and physical custody. Counsel should be familiar with the factors set forth in Montgomery County Dept. of Social Services v. Sanders, 38 Md. App. 406 (1977) and Taylor v. Taylor, 306 Md. 290 (1986) among other applicable cases.
- 22. Alimony: The court may award alimony to either party. (FLA 11-101). Alimony may be awarded pendente lite. (FLA 11-102). The spouse seeking pendente lite alimony must prove the existence of a marriage between the parties, that

- a cause of action for divorce is pending, that the moving party has reasonable financial needs and that the other spouse has the ability to pay (respective financial circumstances). Maynard v. Maynard, 42 Md. App. 47 (1979). James v. James, 96 Md. App. 439 (1993).
- Alimony may be awarded for a definite period or for an indefinite period. FLA 11-106 sets forth the factors which the court shall consider for a fair and equitable alimony award.
- 23. Child support cases: Have your client provide you with applicable documentation of income, existing child support payment, cost of work-related child care expenses, cost of health insurance for the child/children and extraordinary medical expenses and other expenses (e.g., private school expenses). Bring that documentation to the hearing.
- 24. Disposition hearings. When parties reach an agreement and place that agreement on the record in open court the Master / Judge will schedule the case for a disposition hearing date and time by which the original copy of the proposed consent order is to be submitted. that is. actually delivered, to the Master / Judge. The parties and counsel must appear in court for the disposition hearing if the proposed consent order is not timely submitted. It is not acceptable to fax in a copy of a proposed consent order or to leave a telephone message that the proposed consent order is in the mail.

PGCBA EXPUNGEMENT PROJECT | by Ben Rupert

Many people do not appreciate the potential repercussions of a court record documenting a prior criminal case. "I was found not guilty," they might think, "that case was dismissed (or dropped)," or even, "that wasn't me; it was my cousin using my name." While any of those might be true, the fact is that the mere existence of a criminal case *in their name* might be the difference between that person finding gainful employment and being denied the same.

will reveal all cases, civil or criminal, that an individual has been involved as a party. For the employer, this is a prudent practice – I think we all agree that an employer is taking a risk by hiring a convicted thief. The problem for many applicants, however, is that the website reveals all cases, including criminal cases with dispositions of *nolle prosequi*, dismissed, and 'not guilty.' Now, if you were an employer deciding between two equally-

Background checks are part of the employment process for every government job and most large companies. But even small businesses can, and probably should, visit 'Maryland Judiciary Case Search,' a website available to the public that qualified applicants and only one of them had a past charge of theft, who would you hire? The merits of that decision aside, the point is that just one case can make the difference for an individual trying to provide for her or his



family. Luckily for these individuals, the law provides recourse.

It is with the above consideration in mind that the Prince George's County Bar Association has embarked upon our current project: the Criminal Records Expungement Project. One Saturday a month, between February and May 2013, our members are visiting libraries throughout Prince George's County to help residents determine whether their records qualify for expungement, fill out expungement paperwork, and instruct them on the process. Our first event took place at the Largo-Kettering Library on February 23rd. At just that one event, we were able to advise over 50 Prince George's County residents and help complete over 100 petitions for expungement. Our March 23rd event will be held at the Hyattsville Library, where we will have several Spanish-speaking members of the PGCBA present.

The long-term impact of this project can only be speculated, but the idea is as follows: with one less barrier in the way to gaining employment, the residents we help might land a job; with more employed residents, fewer residents will resort to crime as a source of income; with fewer residents resorting to crime, our community becomes a safer and more prosperous place to live and work. The short-term impact is far more certain – we are helping people on a path toward self-improvement, a service for which they are extremely grateful.

As President Bereano mentioned in the February issue of our News Journal, we are in the beginning stages of this exciting new pro bono project. It's not too late to get involved yourself! The project will provide you with a meaningful reason to gather and network with fellow PGCBA members, and something to feel good about. More importantly, you will be helping to provide our great county with a service that can make a significant impact in the lives of our neighbors. On April 27th our members will be at the Clinton Library. Our final event (for now) will be at the Upper Marlboro Library to celebrate Maryland Law Day on Saturday, May 4th. All events are from 10:00 a.m. until 2:00 p.m. Please contact the Bar Association Office if you would like to get involved. The PGCBA thanks the Prince George's County Memorial Library System for their cooperation in this project and for their dedication to a more informed community.

"Proposed Bylaw Change"

Proposed Bylaw Amendment:

It is resolved that Article III: Officers shall be amended as follows:

BOLD CAPS is language added.

A. Officers

- (1) The officers of the PGCBA shall be the President, President-Elect, Treasurer and Secretary, all four (4) of whom shall be Active members of the PGCBA, who shall be elected **AND/OR ELEVATED** at the annual June meeting of the PGCBA for a term of one (1) year, or until their successors are elected and qualified. The Immediate Past President shall also be deemed an officer for purposes of serving on the Board of Directors and the Executive Committee.
- (2) Minimum Qualifications-Officers: Any member may seek nomination, be nominated, stand for election and be elected as SECRETARY of the PGCBA provided he/she shall first have been a member in good standing with the PGCBA for a period of two (2) consecutive years immediately prior to seeking nomination and meet one or more of the following minimum qualifications: (a) have served two years, consecutively or non-consecutively, as a member of the PGCBA Board of Directors, whether by nomination, election or appointment; (b) have served as a committee chair and/or co-chair of any standing or special committee of the PGCBA for a period of two years; or (c) have served as a chair or co-chair of any standing or special section of the PGCBA for a period of two years; or (d) any combination of (a), (b) or (c) above in which the total combinations of capacities served equals two years. THE PERSON WHO SHALLAUTOMATICALLY BE ELEVATED TO THE POSITION OF TREASURER SHALL HAVE SERVED AS SECRETARY DURING THE IMMEDIATELY PRECEDING ONE (1) YEAR TERM. THE PERSON WHO SHALLAUTOMATICALLY BE ELEVATED TO THE POSITION OF PRESIDENT-ELECT SHALL HAVE SERVED AS TREASURER DURING THE IMMEDIATELY PRECEDING ONE (1) YEAR TERM. THE PERSON WHO SHALLAUTOMATICALLY BE ELEVATED TO THE POSITION OF PRESIDENT SHALL HAVE SERVED AS PRESIDENT-ELECT DURING THE IMMEDIATELY PRECEDING ONE (1) YEAR TERM.

Any person who does not meet the minimum qualifications as established herein is disqualified from seeking nomination and/or election, **AND/OR ELEVATION**, to an officer's position of the PGCBA.

B. *President*: The President shall preside at all meetings of the PGCBA, and shall serve as Chairman of the Board of Directors, and shall be an *ex officio* member of all committees of the PGCBA.

The President shall, at the next meeting of the PGCBA following the annual elections OF **SECRETARY AND ELEVATION OF OTHER OFFICERS**, report in writing to the PGCBA on its status and future. At the annual meeting, the President shall report in writing on the PGCBA's accomplishments during the preceding year. These reports, the minutes of all proceedings of the PGCBA, a copy of these ByLaws and any subsequent amendments and a copy of any resolutions adopted by the PGCBA shall become permanent records of the PGCBA and be bound in book form periodically.

The President shall be ineligible to succeed himself in office after he/she has served one (1) full term as President UNLESS THE PRESIDENT-ELECT, AS A RESULT OF DEATH, RESIGNATION, DISABILITY OR OTHERWISE, IS UNABLE TO ACCEPT ELEVATION TO THE POSITION OF PRESIDENT, IN WHICH CASE THE PRESIDENT SHALL BE ELIGIBLE TO SERVE ONE (1) ADDITIONAL TERM

[THIS AMENDMENT CHANGE WILL BE VOTED ON AT THE ANNUAL MEETING ON JUNE 4, 2013]

"Proposed Bylaw Change"

AS PRESIDENT PROVIDED HE/SHE IS APPROVED BY VOTE OF THE BOARD OF DIRECTORS TO SERVE ONE (1) ADDITIONAL TERM AS PRESIDENT.

- C. *President-Elect*: The President-Elect shall assume the duties of the President in the absence of the President. The President-Elect shall automatically become President, without election, at the next annual meeting.
- D. *Treasurer*: The Treasurer shall be responsible for the collection and deposit of funds in the name of the PGCBA in such banks and other financial institutions as the Board of Directors shall direct and shall be responsible for the disbursement and/or withdrawal of said funds by order of the Board of Directors, and shall report at the regular PGCBA meetings and shall keep accounts of the income and disbursements which shall be open to inspection by any member of the PGCBA, and shall propose a budget for the PGCBA to the Board of Directors. **THE TREASURER SHALL AUTOMATICALLY BE ELEVATED TO THE POSITION OF PRESIDENT-ELECT, WITHOUT ELECTION, AT THE NEXT ANNUAL MEETING.**
- E. Secretary: The Secretary shall maintain accurate minutes of all the proceedings and meetings of the PGCBA, the Executive Committee, and the Board of Directors and disseminate them regularly to the membership of the PGCBA (with the exception of the minutes of the Executive Committee meetings, which shall be disseminated to the Board of Directors) and shall conduct the correspondence of the PGCBA.
- F. Vacancies: In the event a vacancy occurs in the office of President, as a result of death, resignation, disability or otherwise, the President-Elect shall perform the duties and functions of that office for the remainder of the term in which such vacancy occurs. The fact that such vacancy is filled by the President-Elect shall not affect the latter's succession to the Presidency at the expiration of the term for which he/she was **ELEVATED** to serve as President-Elect.

In the event of a vacancy in the office of Immediate Past President, the most recent Past President willing or able to serve shall fill that vacancy.

IN THE EVENT A VACANCY OCCURS IN ANY OTHER OFFICE, THE PERSON to fill SUCH vacancy shall be nominated by the Executive Committee and elected by the Board of Directors and such person shall serve in such office until the next annual ELEVATION of officers AT WHICH TIME SUCH PERSON SHALL BE ELEVATED IN THE ORDER OF SUCCESSION SET FORTH IN THIS ARTICLE III, UNLESS THAT VACANCY IS IN THE OFFICE OF SECRETARY. IN THE EVENT THAT THE VACANCY IS IN THE OFFICE OF SECRETARY, THE PERSON TO FILL SUCH VACANCY SHALL BE A MEMBER OF THE BOARD THAT IS THEN SERVING BY ELECTION AND HAS BEEN SERVING AFTER SAID ELECTION FOR AT LEAST TWO YEARS, AND SHALL ALSO FULFILL THE OTHER REQUIREMENTS OF THIS PARAGRAPH FOR ELEVATION AS AN OFFICER AT THE NEXT ANNUAL MEETING.




