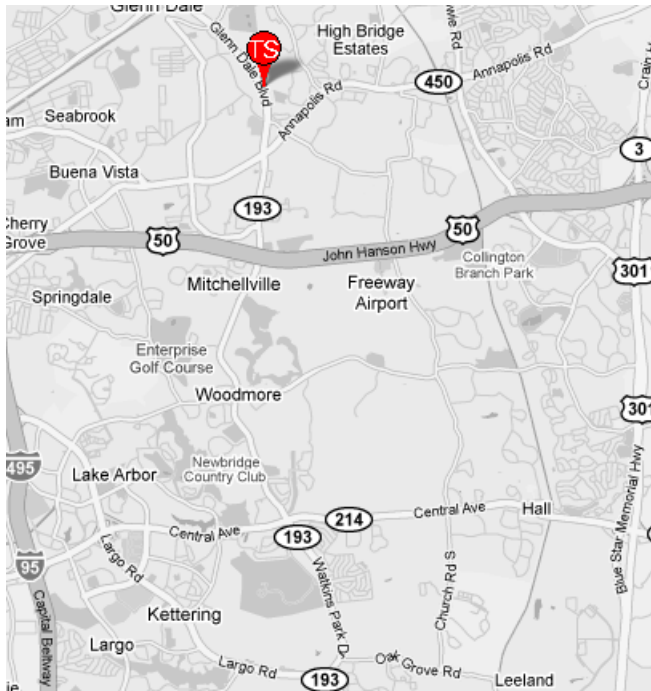
DIRECTIONS

Take Annapolis Road (Rt. 450) east from the beltway to Glenn Dale Blvd (Rt. 193 West).

OR

Take Robert S. Crain Highway (Rt. 301) north to Central Avenue (Rt. 214). Take Central Avenue West to Enterprise Road (Rt. 193 North). At this intersection once you are on Rt. 193 signs will change and should indicate Rt. 193 West. Follow Rt. 193 West to the firehouse on the right. Enter and park in the rear of the building.

TRAFFIC SCHOOL

DRIVER IMPROVEMENT PROGRAM

The driver improvement program sponsored by the Prince George's County Bar Association is a National Safety Council developed and approved course. It consists of two classes, three hours each. The objective of the course is to educate drivers in the prevention of motor vehicle collisions and to encourage safe driving habits. This objective is implemented through the Defensive Driving Course.

THE INSTRUCTORS

- All are accredited by the Accreditation Commission for Traffic Accident Reconstruction.
- All have investigated motor vehicle collisions involving numerous types of vehicles and circumstances.
- All are certified by the National Safety Council as instructors in the Defensive Driving Course.

COURSE CONTENT

Training film/video matched to each session's topic; Case studies and written exercises; Interactive class discussions and exercises; Specific techniques to avoid all types of traffic collisions.

WHAT IS DEFENSIVE DRIVING?

Defensive Driving means developing driving habits that include:

- Making safe and legal driving decisions
- Creating a safe, stress-free personal driving space in and around your vehicle
- Practicing common sense, courtesy, and cooperation
- Recognizing the physical and mental conditions that affect driving
- Knowing defensive driving strategies
- Understanding the conditions of driving
- Being aware of occupant protection

COURSE FEES AND MATERIALS

Total Cost: \$70.00 (CASH OR MONEY ORDERS ONLY, personal checks will not be accepted). Payment must be made at the time of the course. You will need to bring a pen or pencil with you, all other materials are provided.

COURT ORDERED PARTICIPATION

If your participation is related in any way to a court proceeding, failure to attend a scheduled class may result in violation of probation, the imposition of fines and/or other penalties.

TO ENROLL IN TRAFFIC SCHOOL:

Call 301-952-8154 to enroll. You will be assigned to a specific course date. There are a limited number of students per course therefore it is important that you attend the course date you have been assigned. If you do not show up for the assigned course date and need to reschedule there will be \$25.00 rescheduling fee. If you do not receive an assigned course date within two weeks of your court appearance, or if you have a return court date, please contact the Traffic School immediately at 301-952-8154.

*Please be advised this is a **six hour course with a three hour class on Monday evening and a three hour class on Tuesday evening.** You **MUST** attend both evenings in order to complete the course and obtain your Certificate of Completion. If you do not attend the second evening, you will be charged a \$25.00 rescheduling fee, and must attend the second night of class on the next available date.*
